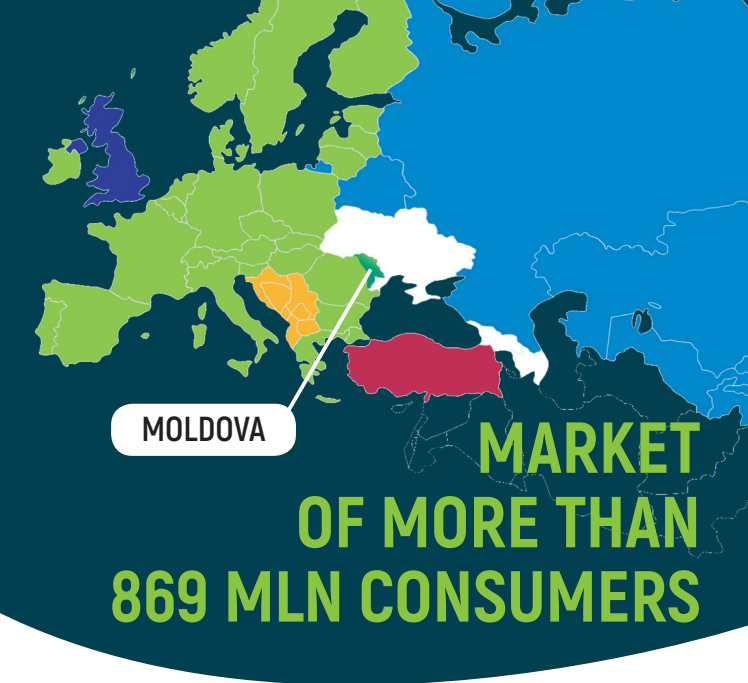

ACTIVITIES WITHIN FEZ

FEZ is part of the customs territory of the Republic of Moldova separated from the economic point of view, in which for domestic and foreign investors are permitted in a preferential regime types of entrepreneurial activities:



Inward processing



Foreign trade



Auxiliary activities

such as rental services, deposit, constructions, etc. necessary to carry out the above mentioned activities.

HOW TO BECOME A RESIDENT?

- 1 Application form for admission to the contest
- 2 Copy of the registration certificate as a subject of entrepreneurial activity in the Republic of Moldova, issued by the Public Services Agency
- 3 Paying the participation fee
- 4 Provide the Business plan for 2-3 years of activity
- 5 Name and surname of the persons, authorized to act on behalf of the contest participants and to sign the legal documents, copy of the identity document, power of attorney
- 6 Copy of the balance sheet for the last year of activity
